## MESSAGE FROM THE BRIDGE



What a summer! From Memorial Day to Labor Day we enjoyed 100 days of gorgeous seasonal weather, amazing community events and countless on-water and beach-front activities. Our Marine Bureau team goes into overdrive to maintain our marinas, beaches and waterways each and every day throughout the summer season. Sometimes it feels like it will never end and at other times it feels like it all goes by way too fast. Well, we made it and now is time to look ahead to the closing of the "hot" season and the coming of the chilly mornings and temperate afternoons of the Fall... maybe. Marine Bureau management continues to implement climate resiliency and sustainability practices into all that we do. Our Beach Maintenance team just rolled out new beachfront trash receptacles that are made from recycled materials and ocean bound plastic. Marine Maintenance is in the process of converting the Marine Stadium Grandstand and our Marine Landscape Maintenance Office to solar powered operation. And

our Marine Operations group is procuring an automated trash and debris collector that can fit between docks and seawalls to better remove waste material from our marina waterways. Our staff looks forward to continuing our climate action efforts and enhancing your marina experience in the process.

We also continue to fill vacant positions across the entire Marine Bureau to meet maintenance and operation needs. Four new Equipment Operators are onboarding to help maintain the beaches, two Electricians are coming aboard to service electrical issues, several Marine Aide positions have been filled to better assist you in our marina offices and in the field and a number of Maintenance Assistant positions are being filled to support custodial and other miscellaneous maintenance.

It is also budget season. With the start of the new City fiscal year on October 1 comes our annual marina slip fee increase. I can report that the FY25 increase is the minimum 2 percent mandated by our 2015 Marina Bond and the City Council. Please take a moment to verify your MarinaGo account payment information on or before October 1 to make certain you understand your billing. Call your marina office in Shoreline or Alamitos Bay if you have questions or need assistance with your account.

Lastly, just because summer is coming to a close it does not mean boating season is over. Long Beach has, on average, over 350 days of sunshine per year. Keep visiting and utilizing your vessel. The best way to maintain your boat is to continue using it.

## THE LATEST NEW ALERTS AND REMINDERS



Marina Offices are open and accepting new vessel permit applications. To provide more comfortable and efficient customer service we have hybrid front desk/window service at ABM and Shoreline offices. Note – Many requests can still be readily handled by phone or email.

**KEYS & FOBS** – Lost, stolen and missing keys and electronic fobs are a priority security issue. **If you have lost or misplaced a marina key or fob contact one of our marina offices immediately.** Staff will record the loss of a numbered key or deactivate a missing fob. Doing this will allow us to better secure marina docks and facilities. If a marina key or fob has been stolen, please address the theft by filing a Report with LBPd. Then provide the completed Police Report to the Marina Office.

Check your MarinaGo account – make sure your contact and payment information is correct and up to date. Marina Fees will increase on October 1, 2024. A one-time fee will also be charged to balance slip deposits to the FY25 Marina Slip Fees.

Unauthorized commercial activity is **ILLEGAL IN LONG BEACH** – Please do not engage in unauthorized commercial activity at, on or near Long Beach Marinas property. Violators can and will be cited and punished to the full extent of applicable law. Reminder – Unauthorized Commercial activity will put your slip permit in jeopardy of cancellation.

## ANNUAL SLIP FEE INCREASE EFFECTIVE OCTOBER 1



On October 1, 2024 Marina Slip fees will increase by 2%. This increase will allow the Long Beach Marinas to meet the 1.25X bond debt service and cover annual changes in personnel and non-personnel expenditures during FY25.

As many of you may recall, the sale of the Marina Revenue Bonds requires that the City maintain a ratio of revenue/ expenditures of 1.25 times the debt service coverage. To ensure this coverage, City Council adopted a policy in May 2015 which states that the annual slip fee increase will be at minimal 2% going into effect each October. This annual slip fee increase will also generate a one-time October 2024 charge to your account to bring your slip deposit into alignment with the new slip fee for FY25. This is demonstrated in the chart below as the “Incremental Increase” for each slip size.

The FY24 and FY25 slip fees are as follows:

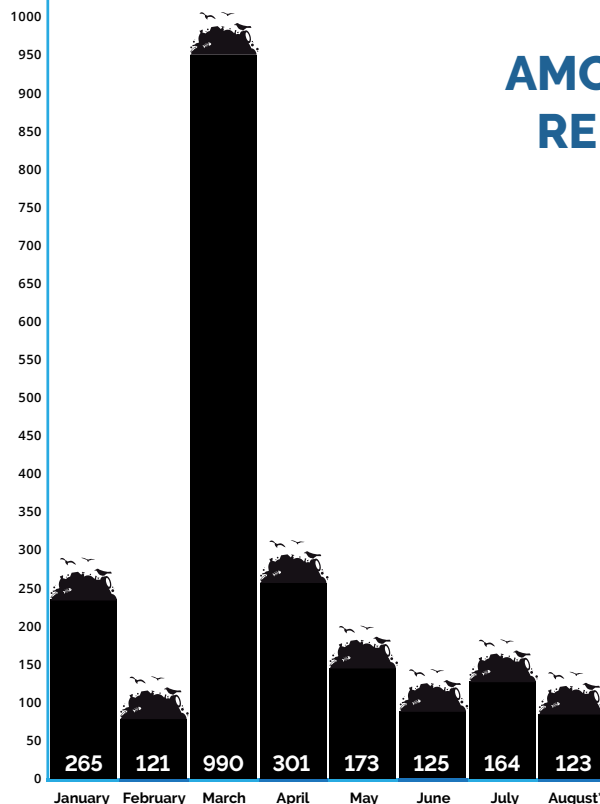

## AMOUNT OF DEBRIS IN TONS REMOVED FROM BEACHES

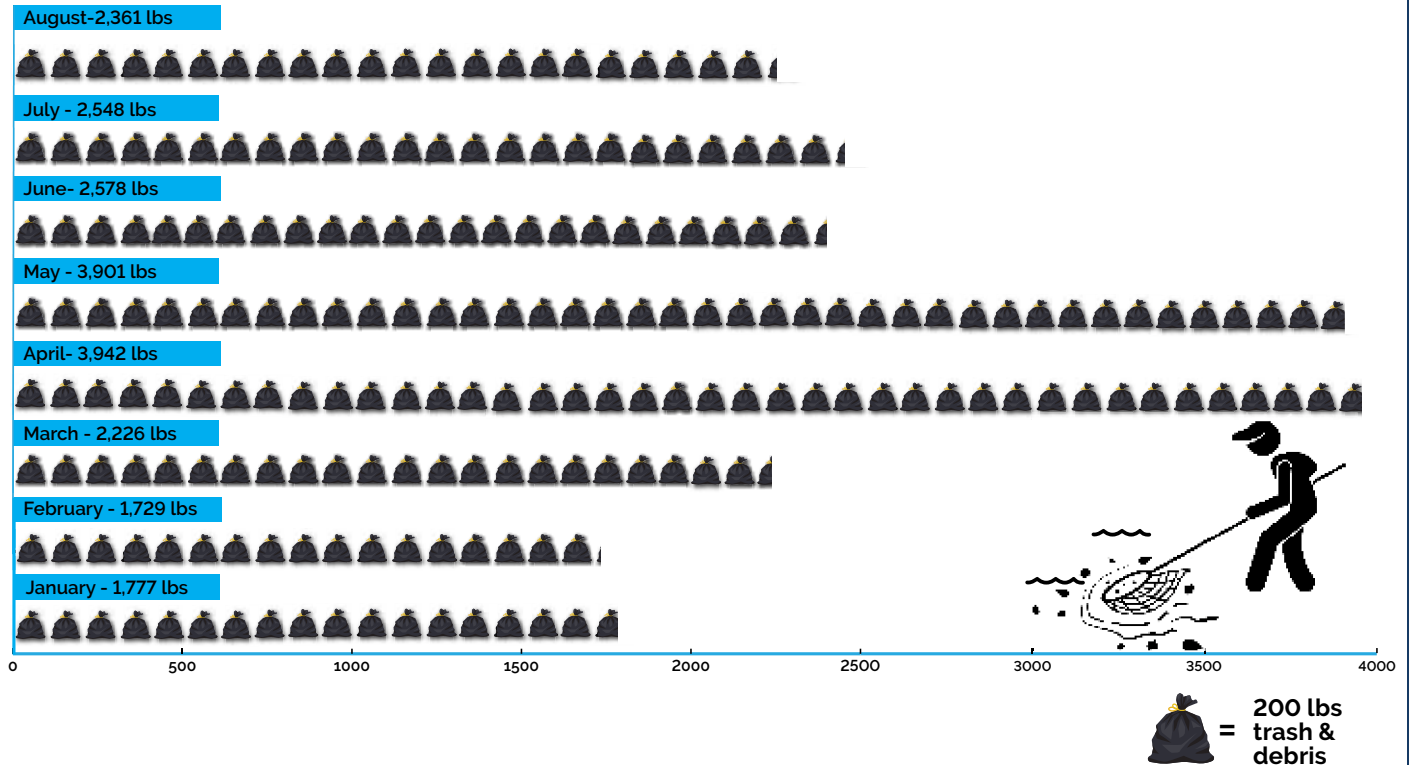
